



Staff Listening Sessions Summary

All staff employed by the School District of Shiocton were given the opportunity to share their thoughts during several days of listening sessions conducted by Hoffman. Our goal is to seek consistency in the thoughts shared during the sessions. We received 737 comments related directly to facility concerns. Other informational comments were received but not included in this summary. We have grouped all input into 57 statements.
