The School District of Shiocton is seeking a Program Support Teacher to serve as a liaison between the Director of Special Education and the building level educators to facilitate program level planning, provide behavioral and instructional supports to staff, and engage in assessments with students during the evaluation process. Review and support of IEP documentation and written documents will also be a responsibility of the PST.

In addition to the Teacher Job Description as per the Professional Staff Handbook, the following are also expected of the Program Support Teacher:

Essential Knowledge and Abilities:

- Objective observation and assessment techniques.
- Administering and interpreting the results of norm-referenced and curriculum-based measures for purposes of instructional design and delivery.
- Other responsibilities related to the referral and evaluation process.
- Problem-solving and progress-monitoring techniques related to the design and implementation of child-specific instruction/intervention strategies.
- Collaborative communication and consultation.
- Providing parents, teachers, and other professional staff with instructional and behavioral strategies to support the progress of students in regular and special education settings.
- Interpretation and application of WI impairment criteria.
- Providing support for special education teachers, therapists, and staff related to drafting and editing IEP paperwork.
- Providing IEP teams with leadership in determining the need for special education.
