Track Project Delayed due to Rain

As the saying goes, "Rain, rain, go away; come again some other day", and certainly, we have been singing that phrase for many weeks now. Despite our efforts, the rains continue to fall, and the timeline to begin the track project continues to be pushed further and further into the summer break.

As of now, work on the track is slated to begin in early August with a completion date late in the month. District officials continue to work with representatives from Athletic Field Services (AFS) regarding the start date and time frame for completion. "While the goal is to minimize the impact the track project will have on the football season, it is a strong possibility that the games scheduled in August may be impacted," commented Mrs. Schweitzer, District Administrator. Mr. Gunderson, Athletic Director, is aware of the potential for conflicting schedules and is looking into alternative options for game locations and dates should such be needed.

New Track, New Tradition

Once completed, the track project will replace the current asphalt with a rubberized running surface. So that the track has proper curing time without concern for food and beverage spills, as well damage from street shoes and heavy apparatus, the new surface will require a new tradition: fans in the stands.

"AFS was clear that the rubberized surface will require different care and use than asphalt. For at least the first year, use of the track will be limited. So as to maintain the warranty, vehicular traffic will not be al-



lowed, nor will the use of bicycles, rollerblades, motorcycles, strollers, and the like," said Mrs. Schweitzer. "We will also need to relocate the stands for our visiting team's fans, as the bleachers can no longer sit on the track surface. Too, our Chief fans will need to plan to watch the game from our home side bleachers or stand along the snow fence that will be erected around the perimeter of the track."

District officials understand this shift to "fans in the stands" (and not on the track) will be a break from tradition but remain confident that the Shiocton community members will support the efforts made to provide improved facilities for the student-athletes.

The District's traditional pathway of education begins with 4-year-old kindergarten and ends with 12th grade; all course work planned meets state standards and is designed in a comprehensive manner to lead the student towards earning a high school diploma.

The District's schools include Shiocton Elementary School (Grades ECH -8) and Shiocton High School (Grades 9-12).

In addition to the traditional, high quality education offered within our classrooms, Shiocton School District seeks to provide educational options to meet the diverse needs and interests of its students. Options include:

REPORT CARD ACCOUNTABLITY RATING

Annually, the Department of Public Instruction (DPI) produces report cards for all publicly funded Wisconsin schools and districts. The report cards share data on multiple indicators in the four priority areas: achievement, growth, target group outcomes, and graduation. For the 2022-2023 school year, the District earned a score of 70.9 (Exceeds Expectations); the elementary school (Grades K4-8) earned a score of 82.0 (Exceeds Expectations); the high school (Gr 9-12) earned a score of 51.2 (Meets Few Expectations).

Student Record Notice

Governed by Board Policy 8330

The Board designates as student "directory information": a student's name; address; telephone number; date of birth; major field of study; participation in officially-recognized activities and sports; height and weight, if a member of an athletic team; dates of attendance; date of graduation; or awards received.

Directory information shall not be provided to any organization for profitmaking purposes.

Parents and eligible students may refuse to allow the Board to disclose any or all of such "directory information" upon written notification to the Board within fourteen (14) days after receipt of the District Administrator's annual public notice or enrollment of the student into the District if such enrollment occurs after the annual public notice.

In accordance with Federal and State law, the Board shall release the names, addresses, and telephone listings of secondary students to a recruiting officer for any branch of the United States Armed Forces or an institution of higher education who requests such information. A secondary school student or parent of the student may request in writing that the student's name, address, and telephone listing not be released without prior consent of the parent(s)/eligible student.

Whenever consent of the parent(s)/eligible student is required for the inspection and/or release of a student's health or education records or for the release of "directory information," either parent may provide such consent unless agreed to otherwise in writing by both parents or specifically stated by court order. If the student is under the guardianship of an institution, the District Administrator shall appoint a person who has no conflicting interest to provide such written consent.

The Board may disclose "directory information", on former students without student or parental consent, unless the parent or eligible student previously submitted a request that such information not be disclosed without their prior written consent.

The Board shall not collect or use personal information obtained from students or their parents for the purpose of marketing or for selling that information.

Only "directory information" regarding a student shall be released to any person or party, other than the student or his/her parent, without the written consent of the parent, or, if the student is an eligible student, without the written consent of the student, except to those persons or parties stipulated by the Board's policy and administrative guidelines and/or those specified in the law.

HS Trades Class Assists with Community Build

The Shiocton High School Construction and Building Trades class recently finished building a storage shed for the Town of Bovina. This project started some time ago as the township needed a structure to store posts, signs, barricades, and other items and were explor-



ing options to acquire a structure when the Bovina Township Chairman, Doug Pahlow, approached the school about the project. This was a mutually beneficial project for both groups as the school gained a great deal of first-hand learning experience on a real-world project and the township is gaining a building.

Early in the project the students met with Pahlow when he outlined his needs for the structure and the class discussed various options for design. The group toured the site at the town hall to learn about how the existing building was designed along with where the new structure would be placed. Next, the group visited Seymour Lumber and worked with a variety of staff that became involved with the project including architectural designers, sales, and estimators. A final plan was created and an estimate was sent to the class and to Bovina.

Once the final approval was issued, the materials were ordered and delivered to the high school so that construction could begin. Over a period of two plus months, the students assembled the building. A ton of building skills were gained in addition to the safety education and experience in material management, project planning (daily and weekly), and customer relationships. The building was finalized on the last day of school and delivered the next week.

This was a fantastic project that the students truly enjoyed and gained a lot of knowledge and experience. Being able to work first hand with the client, designers, estimators, and the many positions that went into this building project was an awesome experience for the students. The School District of Shiocton would like to share a huge thank you to Pete Krabbe and all of the people at Seymour Lumber for being so great to work with on this project. We would also like to extend another big thank you to Doug Pahlow and the Township of Bovina for working with us to create this practical learning opportunity.

SUDDEN CARDIAC ARREST

Sudden cardiac arrest is the leading cause of death in young athletes while training or participating in sport competition. Even athletes who appear healthy and have a normal preparticipation screening may have underlying heart abnormalities that can be life threatening.

What are the symptoms/warning signs of Sudden Cardiac Arrest?

- 1. Fainting/blackouts (especially during exercise)
- 2. Dizziness
- 3. Unusual fatigue/weakness
- 4. Chest pain
- 5. Shortness of breath
- 6. Nausea/vomiting
- 7. Palpitations (heart is beating unusually fast or skipping beats)
- 8. Family history of sudden cardiac arrest at age < 50

ANY of these symptoms/warning signs that occur while exercising may necessitate further evaluation from your physician before returning to practice or a game.

SUDDEN CARDIAC ARREST VS. HEART ATTACK

Sudden Cardiac Arrest (SCA)

SCA is a chaotic electrical condition of the heart fibrillation.

Definition

Typically, there are no symptoms to SCA. Usually, Symptoms the first indication of SCA is when the victim faints. jaw. Other signs include bad indigestion, a feeling that The second sign is breathing cessation.

Victim's A sudden cardiac arrest victim always loses consciousness from lack of oxygen. untreated, the chances of survival decrease by 10% Most victims can recover fully and lead normal lives, but about Risk of Death per minute. Typically, permanent brain damage occurs within 5-7 minutes.

The only treatment for SCA is defibrillation from an automated external defibrillator (AED). A shock Treatment from the AED stops the chaotic electrical activity and allows the heart's sinus node to resume a normal electrical impulse.

Heart Attack

The medical term for a heart attack is myocardial infarction: a resulting in the loss of blood flow to the brain and blockage of the coronary arteries leading to a decrease in body. The most common form of SCA is ventricular blood flow. When this happens, the heart muscles die or become permanently damaged.

Electrical impulses of the heart become chaotic due Plaque made of cholesterol and other cells builds up in the walls of the heart's arteries. When the buildup is great enough, the plaque creates a blockage, known as an occlusion, which restricts the blood supply to the heart muscle.

> Warning signs of heart attack include a tightening feeling in the chest, a sore or numb left arm, lower back, neck, and/or something heavy is sitting on your chest, and shortness of

The victim of a heart attack is usually conscious and alert.

a third of heart attacks are deadly. A heart attack can lead to sudden cardiac arrest

One treatment of a heart attack can be angioplasty, which opens up the blocked vessels with a medical balloon. Afterwards, a stent can be placed in the artery to help keep it open. Other treatments include clot-busting drugs called thrombolytics or nitroglycerin to reduce chest pain.

RELEASE STATEMENT

The School District of Shiocton announced its policy for children unable to pay the full price of meals served under the National School Lunch Program and School Breakfast Program or milk for split-session students served under the Special Milk Program. Each school office and the central office has a copy of the policy, which may be reviewed by any interested party.

The following household size and income criteria will be used for determining eligibility. Children from families whose annual income is at or below the levels shown are eligible for free and reduced price meals or free milk if a split-session student does not have access to the school lunch or breakfast service.

Application forms are being sent to all homes with a notice to parents or guardians. To apply for free or reduced price meals or free milk, households

must fill out the application and return it to the school (unless notified at the start of the school year that children are eligible through direct certification). Additional copies are available at the office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by agency or other program officials. Applications may be submitted at any time during the year.

To obtain free or reduced price meals, or free milk, for children in a household where one or more household members receive FoodShare, Food Distribution Program on Indian Reservations (FDPIR), or Wisconsin Works (W-2) cash benefits, list the FoodShare, FDPIR or W-2 case number, program name, list the names of all school children, sign the application, and return it to the school office.

For the school officials to determine eligibility for free or reduced price meals or free milk of households not receiving FoodShare, FDPIR or W-2 cash benefits, the household must provide the following information requested on the application: names of all household members, total number of household members, and the adult signing the application form must also list the last four digits of his or her Social Security Number or mark the box to the right of "Check if no SSN". Also, the income received by each household member must be provided by amount and source (wages, welfare, child support, etc.).

Under the provisions of the free and reduced price meal and free milk policy, Heather Knops, Food Service Director N5650 Broad Street PO Box 68 Shioc-

ton WI 54170 920-986-3351 x816 will review applications and determine eligibility. If a parent or guardian is dissatisfied with the ruling of the official, he/she may wish to discuss the decision with the determining official on an informal basis. If the parent/guardian wishes to make a formal appeal, he/she may make a request either orally or in writing to: *Nichole Schweitzer, District Administrator, N5650 Broad Street PO Box 68 Shiocton, WI 54170 920-986-3351 x761.*

If a hearing is needed to appeal the decision, the policy contains an outline of the hearing procedure.

If a household member becomes unemployed or if the household size changes, the family should contact the school. Such changes may make the household eligible for reduced price meals or free meals or free milk if the household income falls at or below the levels shown above, and they may reapply at that time.

Children formally placed in foster care are also eligible for free meal benefits.

Foster children may be certified as eligible without a household application. Households with foster children and nonfoster children may choose to include the foster child as a household member, as well as any personal income available to the foster child, on the same application that includes their non-foster children.

The information provided by the household on the application is confidential. Public Law 103-448 limits the release of student free and reduced price school meal eligibility status to persons directly connected with the administration and enforcement of federal or state educational programs. Consent of the parent/guardian is needed for other purposes such as waiver of textbook fees.
