*Shall the School District of Shiocton, Outagamie County, Wisconsin be authorized to exceed the revenue limit specified in Wis. Stat. 121.91 by the following amounts in the school years specified: \$1,525,000 in 2021-2022; \$1,700,000 in 2022-2023; and \$1,875,000 in 2023-2024, for non-recurring purposes, such excess to be used to finance ongoing operational expenses to maintain current educational programs of the District?*

Motion by Mr. Gomm with a second by Mr. Pluger to approve the Ballot Question as amended. Motion carried. (Roll Call 6-0)

Discuss and Take Action: **Explanatory Statement and Effect of Vote**

*Explanatory Statement and Effect of Vote:*

*The referendum election ballot will ask District electors to vote “yes” or “no” on the referendum election question as set forth above.*

*A “yes” vote is a vote to approve the School District of Shiocton to exceed the revenue limit specified in Wis. Stat. 121.91 by the following amounts in the school years specified: \$1,525,000 in 2021-2022; \$1,700,000 in 2022-2023; and \$1,875,000 in 2023-2024, for non-recurring purposes, such excess to be used to finance ongoing operational expenses to maintain current educational programs of the District.*

*A “no” vote is a vote to deny the School District of Shiocton the authority to exceed the revenue limit specified in Wis. Stat. 121.91 by the following amounts in the school years specified: \$1,525,000 in 2021-2022; \$1,700,000 in 2022-2023; and \$1,875,000 in 2023-2024, for non-recurring purposes, such excess to be used to finance ongoing operational expenses to maintain current educational programs of the District.*

*In the event a majority of the electors voting vote “yes”, the District will be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,525,000 in*

*2021-2022 school year, \$1,700,000 in 2022-2023 school year, and \$1,875,000 in 2023-2024 school year, for non-recurring purposes, to finance ongoing operational expenses necessary to maintain current educational programs of the District; if a majority vote “no” on the question set forth above, the District will not be so authorized.*

Motion by Mrs. Warning with a second by Mr. Gomm to approve the Explanatory Statement and Effect of Vote as amended. Motion carried. (Roll Call 6-0)
