Growing Today; Planning for the Next Generation

In February of 2021, voters approved a three-year, \$5.1 million dollar non-recurring operational referendum. Now, in the final of the three years, these funds continue to support the operations of the District. Everything from lights, computers, and internet to staff, instructional programming, and extra-curricular offerings are funded by the referendum.

GROWING TODAY

We continue to grow in our programs and offerings for our current students. Last year, based upon data collected, the District added a third 4K teacher and paraprofessional. The addition of these staff members allowed us to grow our 4K instruction, providing three classrooms for all-day 4K four days per week (Monday-Thursday). Our 4K educators could see the difference that this continuous stream of instruction made for our young learners; their growth in both the pre-academic skills, as well as their socioemotional abilities to attend and work collaboratively, grew exponentially by the end of the 2022-2023 school year.

Also during the 2022-2023 school year, the District added a part-time **Behavioral Interventionist**. Similar to our math and reading interventionists, the Behavioral Interventionist works one-on-one and in small groups with students to help them recognize and manager their emotions and behaviors. The Behavior Interventionist also works with educators and paraprofessionals to recognize students' triggers and then to reconfigure instruction and the learning environment to assist the students in being more successful learners.

In the 2023-2024 school year, we will capitalize on the final ESSER III (COVID) dollars to support the addition of a School Social Worker. This person will also be responsible for working with students both one-on-one and in small group. Together, the School Social Worker will assist students as they deal with challenges they are experiencing and help them in meeting a variety of needs. Often, the needs are related to concerns within their environments outside of the school such that the School Social Worker will provide a conduit to wrap-around services for children and for parents. Too, the **School Social Worker** will lead our Building Consultation Team (BCT) as we record and monitor various reading, math, and behavioral interventions that prepare our learners with grade-level academic and socioemotional skills and knowledge sets.

This school year will also see a continuation of our implementation of **Conscious Discipline** as we continue to build our own skills and knowledge while fostering the same growth in our learners. We will also begin a focus on **restorative practices**, which focuses our efforts on fostering a sense of community within our classrooms and learning groups. Through these approaches, our goal is to minimize conflict between students while growing their ability to manage their emotions, accept responsibility for their actions, and (re)build healthy/healthier relationships.

We will also continue our efforts to align our **curriculum** to Wisconsin State Standards. In Grades 7 and 8, we will continue our work in the History, Geography, and Economics courses. We will also stay abreast of the rules and expectations that come with the new reading law and required training in the Science of Reading. Elementary teachers will begin implementing Mystery Science this year, which offers increased student engagement through hands-on activities. With a successful launch of the Trap Shooting team, we turn our focus to the **extra-curricular offerings** at the middle level. Specifically, we will be exploring options for the Spring season when the only athletic team offered to them is Track and Field.

PLANNING FOR THE NEXT GENERATION

As much as we focus on needs of and offerings for today's learners, we must also look ahead ... WAY ahead ... 20 to 30 years from now ... to ensure that we are setting the stage well for the next generation. The Facility Study conducted in Fall 2022 revealed some significant gaps and areas of need related to both our infrastructure, as well as the physical building and internal capacities. Over the course of the past six months, the **Building Project Committee** (a Board of Education ad-hoc committee) sifted through the pages of feedback from children to adults, seeking those projects that would provide the greatest return on investment related to growth for the next generation.

After many hours of review and revision, the Building Project Committee chose to advance five projects for further consideration by the public. The **Prioritized Projects** include:

- repair/replace aging and failing infrastructure (plumbing, piping, electrical, HVAC, etc.);
- remodel and build safe and secure entrances for the MS/HS and elementary schools;
- remodel and build a Technical Education wing;
- build a Child Care Center wing;
- build a gym with side-by-side practice courts, remodel current locker room facilities, and remodel/build a fine arts wing for vocal and instrumental instruction

The cost projections for the completion of these projects ranges from \$30-\$35 million, which would be phased in for tax purposes over a three to four year timespan. Feedback from the **Community Connection** meetings held in August indicated that well over 90% of those in attendance would support a building referendum comprised of all five projects.

Shiocton Child Care Center: Continued Growth on the Horizons

Speaking of growing, the Shiocton Child Care Center (SCCC) continues to see robust interest in enrollment. Having most recently celebrated a full five (5) years in operation, SCCC's enrollment has grown from 18 children in August of 2018 to 91 children as of September 2023. With a waiting as high as 40 children, child care services continue to be in great demand in our community. The on-site child care is of great interest to parents both in and out of our school district, as it provides a "one-stop-drop" for all children, ages 6-weeks to 9-years-of-age, as the children can simply walk down the hall from care to class and back — no additional travel or transportation needed. The on-site child care center is also a significant benefit to our staff members. With nearly 25 of the enrollees being children of our own educators, SCCC is a tool for both attraction and retention of high-quality educators and support staff. As SCCC grows, the need for their own expanded space becomes evermore necessary.

Without a doubt, there is much to look forward to as we continue to grow the quality and quantity of both academic and extra-curricular programs offered today in our District, while planning with the future generation in mind.

Mill Rates Remain Under Projections

We are in the third year of the three year referendum, which spans the Fiscal Years 2022—2024. Mill rates for the three years were expected to range from \$10.09 to \$10.25. Our efforts continue to be two fold: (a) realize the greatest return on our investment while (b) serving as strong stewards of the tax payer's dollars. While the referendum approved included a mill rate of \$10.09 for the 2021-2022 school year, we were able to realize a mill rate \$1.02 less than projected, for a final mill rate of \$9.07.

Again last year, 2022-2023, we were able to maximize our funding by adding to our pupil enrollment and capitalize on grants. Combined with an increase in property valuation, the District was able to *lower* the actual mill rate charged to tax payers by \$2.42. While there are still many unknown factors that will influence the final mill rate for the 2023-2024 school year, we do not expect the mill rate to exceed \$10.00, which would be a minimum *decrease* from the projected rate of twenty-five cents.

Treasurer's Report 2022-2023

Audited Figures

Fund 10 General Fund: Audited revenue for the 2022-23 fiscal year was \$254,497 more than budgeted. Expenses were \$9,870 less than budgeted. The district's Fund Balance decreased by \$252,290 to \$3,874,516 or 33.84% of the operational budget.

Fund 21 Special Revenue Trust Fund: In October 2009, the district received a \$300,000 donation to be used over time to support efforts in promoting students to pursue the areas of Science, Technology, Engineering, and Math (STEM). The current balance is \$211,860. In the spring of 2018, the district received total donations of \$110,000 to be used for fitness and weight equipment in the Multi-Purpose Facility. The current balance is \$96,692. Beginning with the 2020-2021 Fiscal Year, all student activity funds and all scholarship funds are accounted for and operating through Fund 21. Previously, these funds were in Fund 60 or 72. The student activity fund has a current balance of \$179,444. The scholarship funds current balance is \$18,735.

Fund 27 Special Education: This fund tracks all special education costs. A transfer of \$839,038 was made from the General Fund 10 to the Special Education Fund 27 to cover costs not reimbursed through State Categorical Aid or Federal Flow Through Funds.

Fund 38 Non-Referendum Debt Fund: This fund consists of a Bond Issue for the Unfunded Pension Liability. There were no Expenditures for the 2022-23 fiscal year; this 10-year note was paid in full in March 2022 (FY22).

Fund 39 Referendum Debt Fund: This fund had a separate levy of \$251,938 used for the purpose of funding referendum debt.

Fund 50 Food Service Fund: Food service revenues were \$49,068 more than budgeted, and expenses were \$55,004 more than budgeted. The revenue increase was due to the continued higher claim reimbursement than budgeted and additional revenue under the Supply Chain Assistance program. The increase in expenses related to economic factors (inflation and supply chain) over the entire school year. Overall food service will end with a fund balance of \$277,565.

Fund 73 Employment Benefit Trust Fund: At the end of the 2022-23 fiscal year Fund 73 is fully funded with a balance of \$983.990.

Fund 80 Community Service Fund: Fund 80 has a separate levy of \$174,169 and ended the year with a balance of \$74,058. During the 2022-23 school year, funds were used to support a Flag Football team for girls and boys in Grades K – 7th. Funds also supported the fitness center for community members six days per week; supervision was provided for safety and support purposes. This was the fifth year for the Shiocton Child Care Center which opened in August 2018. Revenue for SCCC 2022-23 fiscal year was \$99,609 more than budgeted, and expenses were \$41,112 more than budgeted. Most of the increased revenue was due to additional grant funds from the Department of Children and Families. These funds were granted in an effort to address increased operational costs due to COVID-19 and other economic factors.

Grades 7-12 Highlights from the 2022-2023 School Year:

The 2022-2023 school year proved to be a very exciting year for our school community. Many new initiatives were embarked upon, and our school district showed success both in and out of the classroom. Our school staff members continued to show their dedication to the educational and personal growth of all of our students. This relationship building and the genuine care that we show for each other and our students has a direct, positive impact on student success.

In Grades 9-12, we continued our Academic and Career Planning through the Xello program. High school students met with our school counselor throughout the year to help plan future classes and what their career path may be. Our School-to-Work offerings continue to grow through Youth Apprenticeship and the continued expansion of our Out-of-School Work Experience program. In looking purely at academics, our ACT scores in English were the highest they have been since the ACT test was mandated for all students. We also showed improvement in our ACT college ready percentages in Science and English. Our ACT Math composite scores remained steady from previous years. We also expanded our "See Something, Say Something" curriculum into the high school to help our students learn important safety skills. At both the high school and middle school, we also did an analysis with staff, parents, and students regarding our grading scale. The decision was made to change it to be more equitable for college admissions and scholarships.

In Grades 7-8, we greatly improved and expanded our EMLSS (Equitable Multi-Level Systems of Support) processes. EMLSS, formerly known as RtI, describes all of the academic and behavioral interventions that our staff members put in place to help our students be successful academically, socially, emotionally, and behaviorally. We also continued our work with the "See Something, Say Something" curriculum in Grades 7 and 8. We continued our work on our revamped ELA curriculum. A committee was put together that decided a change to our schedule was necessary to get all of the new ELA curriculum in. That change will be in place during the 2023-2024 school year. In terms of academics, our 8th grade had a higher percentage of students who are proficient or advanced than the state average in ELA and Science. Our 7th grade had a higher percentage of students who are proficient or advanced than the ELA average in and Math.

Outside of the classroom, Shiocton had one of its

most successful years in our athletic history. Our football team made it all the way to the State Championship last year for the first time since 2013. We are very proud of their achieve as the State Runner-Up. Our volleyball team was very competitive. They showed a great deal of effort and improved throughout the year in a very difficult conference. Our cross country team saw our first State Qualifier, Ava Lorenz, since the rebirth of the program. Boys' basketball team won the CWC Conference championship while the girls' basketball team battled through a tough conference schedule and won a regional playoff game. Our wrestling team won their third straight conference title, and the team made it to the State Championship meet in Madison, sending a record nine (9) individual state qualifiers and setting a school record. Our trap shoot team finished second in their conference and fifth overall at the State competition. Jacob Schley, sophomore, finished as the top rated trap shooter in the state during the regular season. Our golf team grew rapidly throughout the year and set the stage for success this coming school year. The softball team battled through a tough conference schedule, while the baseball team won their first CWC Conference title in 19 years, advancing to the Regional Championship game. Our girls' track team earned the Conference Championship and a team Sectional title. The boys' track team won the Regional Team Championship and went on to win the WIAA State Championship for their division. There were 14 individual events that qualified for the State Track meet. Cade Stingle took home individual state championships in the 110m hurdles and 300m hurdles.

Our school-sponsored academic groups were also successful last year. Our Quiz Bowl B Team took home second place in the CWC Conference. Our Math League enjoyed returning to in-person meets twice last year, and improved their scores throughout the year. The band and choir students put on wonderful performances for our Winter Concert and our Spring Showcase. They also enjoyed a return for their first Band/Choir trip since the start of the pandemic.

During the 2023-2023 school year, our school staff did a wonderful job of supporting our students and helping them grow. Our student body showed that they were strong both in and out of the classroom. Our students and staff will continue to forge forward and continue to make Shiocton a place where everyone can see success. There will always be new challenges, but we have built skills among our school community to take those challenges on, and achieve what we set our minds to.

Grades PK-6 Highlights from the 2022-2023 School Year

As we started the 2022-2023 school year, it was refreshing to have students engaging in field trips again. It was wonderful to be able to send our fifth grade students back to Camp U-Nah-Li-Ya for their environmental education experience. Students at the PK-6 level visited other places such as Buboltz Nature Center, the Fox Cities Performing Arts Center, Building for Kids, museums, airports, Bay Beach, Madison, Barlow Planetarium, Mosquito Hill, Weidner Center, N.E.W. Zoo, Navarino Nature Center, etc. Oh, what fun!

Going into the school year, there continued to be a substitute teacher shortage. To cover the daily absences, the district hired three substitute teachers as regular staff members. We really could not have done it without all of this support!

At the PK-6 level, we are always looking to learn and grow ourselves as individuals, as grade level teams, as departments, and as an entire staff. As we progressed through the year, staff members continued to focus their time and energy on curriculum work, building positive relationships with students. implementing Conscious Discipline strategies, implementing additional strategies supports to promote positive mental health and social emotional learning, and their own professional growth and development. Teachers worked hard to create classrooms that were calm spaces for our students. "Less is more" became our new way of thinking to create these calmer learning environments. This is just a little snippet of things we worked on this year. I am so proud of our entire PK-6 team for their incredible work during the 2022-2023 school year!

Due to an increase in meeting the needs of the students at the elementary level, a Behavioral Interventionist position was created. Mrs. Streblow, a former Shiocton first and fourth grade teacher, filled that role. What an incredible addition this was for the 2022-2023 school year! I cannot emphasize enough how much this position was necessary and how valuable Mrs. Streblow's daily efforts with students proved to be. Mrs. Streblow will continue to serve in this role going into the next school year.

We closed out the year with a wonderful summer school experience during the month of June.
