- a. **Set the Levy:** Motion by Mr. Gomm with a second by Mrs. Warning to levy upon the taxable property of the School District of Shiocton the sum of \$4,238,221 for defraying the cost of operation and maintenance of the public schools, \$241,800 for referendum approved debt, and \$74,500 for the community service fund for a total levy of \$4,554,521 and a mill rate of \$8.50 per thousand dollar of equalized value. Roll call. Motion carried. 6-0.
- b. Discuss and Take Action on Donation: Snortum Family (Playground Fund) . Motion by Mr. Birch with a second by Mrs. Hofacker to accept the donation of \$500 on behalf of the Snortum Family for the playground fund. Motion carried. 6-0.
- c. Discuss and Take Action on Donation: East Wisconsin Saving Bank (Playground Fund). Motion by Mrs. Warning with a second by Mrs. Hofacker to accept the \$500 donation by East Wisconsin Savings Bank. Motion carried. 6-0.
- d. Discuss and Take Action on Donation: Better Life Insurance/Shari Allen (Playground Fund). Motion by Mr. Gomm with a second by Mrs. Schmidt to accept the donation of \$7,600 from the playground ticket raffle by Better Life Insurance and Shari Allen for the playground fund. Motion carried. 6-0.
- e. Discuss and Take Action on Donation: Boomin Brothers, LLC (two picnic tables for the playground). Motion by Mr. Gomm with a second by Mr. Birch to accept the donation of \$3,380 to purchase two picnic tables for the playground. Motion carried. 6-0.
- f. Discuss and Take Action on Bleacher and Press Box Project. Motion by Mr. Gomm with a second by Mr. Birch to approve the Bleacher and Press Box Project contingent upon sufficient funding. Motion carried. 6-0.
