**BE IT RESOLVED** by the School Board of the School District of Shiocton, Outagamie County, Wisconsin that the revenues included in the School District budget be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$2,200,000 for the 2024-2025 school year, by \$2,500,000 for the 2025-2026 school year and by \$2,700,000 for the 2026-2027 school year, for non-recurring purposes consisting of ongoing operational expenses necessary to maintain the educational programs of the District.

Discuss and Take Action on **Initial Resolution Authorizing General Obligation Bonds in an Amount Not to Exceed \$35,800,000**

**BE IT RESOLVED** by the School Board of the School District of Shiocton, Outagamie County, Wisconsin that there shall be issued pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$35,800,000 for the public purpose of paying the cost of a District-wide school building and facility improvement project consisting of: construction of additions, including for technical education, a gymnasium, band and choir, a child care center, district offices and safe and secure entrances; renovations, capital maintenance, building infrastructure, systems and site improvements, including playground equipment and updates; and acquisition of furnishings, fixtures and equipment.
