4K is FOUR DAYS; TRAP SHOOT APPROVED

Earlier this summer, the Board of Education approved the expansion of the District's 4K program to four full days per week.

"Growing our 4K program to four full days per week was the next natural step in ensuring a quality education is provided to all of our learners," noted Nichole Schweitzer, District Administrator. Data digs revealed that students attending the current schedule of two days per week would experience pre-academic and social/ emotional instruction a maximum of 72 days. The normal school year is 178-180 school days. This lack of attendance coupled with academic gaps identified through assessments drove the request to grow the 4K program. "Between COVID absences, general illnesses, and days off in the school calendar due to professional development and holidays, some students only attended 56—62 days. The gaps in attendance naturally result in gaps in instruction, which creates gaps knowledge and overall readiness for learning as a kindergartner."

Understanding that some 4-year-old children may not be ready for four full days, the Board also approved a four-

FACILITY STUDY UNDERWAY

At the July 18, 2022 Board of Education meeting, the Board unanimously approved hiring the firm of Hoffmann Planning, Design, and Construction to conduct a full-scale facility study for the School District of Shiocton.

The purpose of the Facility Study is two-fold. First, the study will provide an in-depth look at current capacity of the structure, systems, and programs. Second, the study will provide a list of areas in need of improvement, as well as opportunities for growth based upon a Priority Matrix that takes into account the return on investment in categories such as stu-

half-day option whereby parents can enroll their child in 4K for just the four mornings: 7:57—11:15AM, Monday through Thursday. While students can participate in the district sponsored transportation for the AM trip into school, parents are responsible for transporting the child at the end of the half day (11:15AM).

The Board of Education also heard from several members of the high school Trap Shoot team, which saw a very successful pilot year. Students shared with the Board what they had learned through the sport. Coach Schley spoke to the strong level of interest and the skill development seen over the course of the season, which included a Conference Championship for both the junior varsity and varsity teams. The Board unanimously voted to approve the Trap Shoot Team as an official cocurricular offering in the high school athletic department beginning with the 2022-2023 school year.

The next Board meetings are scheduled for August 1 and August 15. Meetings are held in H139 and begin at 6:00PM.

RELEASE STATEMENT

The School District of Shiocton today announced its policy for children unable to pay the full price of meals served under the National School Lunch Program and School Breakfast Program or milk for split-session students served under the Special Milk Program. Each school office and the central office has a copy of the policy, which may be reviewed by any interested party.

The following household size and income criteria will be used for determining eligibility. Children from families whose annual income is at or below the levels shown are eligible for free and reduced price meals or free milk if a split-session student does not have access to the school lunch or breakfast service.

Application forms are being sent to all homes with a notice to parents or guardians. To apply for free or reduced price benefits or free milk, households must fill out the application and return it to the school (unless notified at the start of the school year that children are eligible through direct certification). Additional copies are available at the office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by agency or other program officials. Applications may be submitted at any time during the year.

To obtain free or reduced price benefits or free milk for children in a household where one or more household members receive FoodShare, FDPIR, or Wisconsin Works (W-2) cash benefits, list the FoodShare, FDPIR or W-2 case number, program name, list the names of all school children, sign the application, and return it to the school office

For the school officials to determine eligibility for free or reduced price benefits or free milk of households not receiving FoodShare, FDPIR or W-2 cash benefits, the household must provide the following information requested on the application: names of all household members, total number of household members, and the adult signing the application form must also list the last four digits of his or her Social Security Number or mark the box to the right of "Check if no SSN". Also, the income received by each household member must be provided by amount and source (wages, welfare, child support, etc.).

family should contact the school. Such changes may make the household eligible for free or reduced price benefits or free milk if the household income falls at or below the levels shown above, and they may reapply at that time.

Children formally placed in foster care are also eligible for free meal benefits. Foster children may be certified as eligible without a household application. Households with foster children and non-foster children may choose to include the foster child as a household member, as well as any personal income available to the foster child, on the same application that includes their non-foster children.

The information provided by the household on the application is confidential. Public Law 103-448 limits the release of student free and reduced price eligibility status to persons directly connected with the administration and enforcement of federal or state educational programs. Consent of the parent/guardian is needed for other purposes such as waiver of textbook fees.

DISTRICT EARNS PROJECT ADAM SCHOOL SAVE HEART CERTIFICATION AGAIN

School nurse, Amy Austin, was pleased to receive word that the School District of Shiocton had once again earned the Project Adam School Save Heart certification. The certification is earned by schools who have implemented a quality sudden cardiac arrest program. That program must include training in CPR and AED machines, as well as building awareness of cardiac arrest and maintaining an effective emergency response team to ensure a safe environment for students, staff, and visitors.

Mrs. Austin oversees a staff-based emergency response team comprised of school personnel. Team members maintain their CPR and AED certification and train multiple times throughout the school year to keep their skills and knowledge up-to-date.

SUDDEN CARDIAC ARREST

Sudden cardiac arrest is the leading cause of death in young athletes while training or participating in sport competition. Even athletes who appear healthy and have a normal preparticipation screening may have underlying heart abnormalities that can be life threatening.

What is Sudden Cardiac Arrest?

- 1. Occurs suddenly and often without warning.
- 2. An electrical malfunction (short-circuit) causes the bottom chambers of the heart (ventricles) to beat dangerously fast (ventricular tachycardia or fibrillation) and disrupts the pumping ability of the heart.
- 3. The heart cannot pump blood to the brain, lungs and other organs of the body.
- 4. The person loses consciousness (passes out) and has no pulse.
- 5. Death occurs within minutes if not treated immediately.

What are the symptoms/warning signs of Sudden Cardiac Arrest?

- 1. Fainting/blackouts (especially during exercise)
- 2. Dizziness
- 3. Unusual fatigue/weakness
- 4. Chest pain
- 5. Shortness of breath
- 6. Nausea/vomiting
- 7. Palpitations (heart is beating unusually fast or skipping beats)
- 8. Family history of sudden cardiac arrest at age < 50

ANY of these symptoms/warning signs that occur while exercising may necessitate further evaluation from your physician before returning to practice or a game. ** Note that a student-athlete who exhibits unexplained fainting may be SCA because it is the number one warning sign of a potential heart condition. **

There is potential for effective secondary prevention of sudden cardiac death by having automated external defibrillators (AEDs) easily accessible and trained staff available. The presence of trained individuals and access to AEDs at sporting venues provides a potential means of early defibrillation, not only for athletes but also for spectators, coaches, officials, event staff and other attendees in the case of sudden cardiac arrest.

It is advisable to have an <u>Emergency Action Plan</u> in place for all sport practice and competition sites that outlines the plan of action in case of the sudden collapse of an athlete. It is advisable to review and practice the emergency action plan with respective school personnel, coaches, on site medical personnel and local EMS.

Time is Critical: If not properly treated within minutes, SCA is fatal in 92% of cases.

Basic actions include:

- 1. Have a cell phone available at all venues
- 2. Immediately activate EMS
- 3. Immediately initiate continuous CPR (push hard, push fast, push often)

Your school's medical personnel (team physician, licensed athletic trainer, school nurse) and/or local EMS may wish to assist in the development and implementation, if not already in place, of the <u>emergency preparedness plan</u> for the management of the collapsed athlete. the "Interassociation task Force recommendations on emergency Preparedness and Management of sudden cardiac arrest in high school and college athletic Programs; a "consensus statement" is one source of guidance as to the development and implementation of an emergency action plan for the

management of sudden cardiac arrest in an athlete.

What are ways to screen for Sudden Cardiac Arrest?

- 1. The American Heart Association recommends a pre-participation history and physical including 12 important cardiac elements.
- 2. The WIAA Pre-Participation Physical Evaluation Medical History form includes ALL 12 of these important cardiac elements and is mandatory bi-annually.
- 3. Additional screening using an electrocardiogram and/or an echocardiogram is readily available to all athletes, but is not mandatory.
