Building Project Update: finalize prioritized projects, hosting community meetings

The Building Project Committee met on June 28 and again on July 19 in an effort to finalize the projects that will be shared with community during the month of August.

"There were many competing needs as highlighted by the results of the Facility Study. The Committee finalized the projects it feels best meet those competing needs while also preparing the District for future growth. We are looking forward to hearing the community's thoughts during the meetings next month," commented Nichole Schweitzer, District Administrator.

The chosen prioritized projects include:

Infrastructure updates - replacing 1962 domestic waterlines and softeners; replacing 1996 pumps, pipes, and frequency drives; replacing main electrical service equipment and panel boards installed prior to 1996; replacing the generator, transfer switches, chillers, and some roofs.

Building Security: Elementary - construct a new elementary office off the kindergarten wing with double vestibule, secured entrance

Building Security: Middle/High School - construct a new middle/high school office off the choir wing with double vestibule, secured entrance; relocate the Choir room to capital-ize on current space

Technical Education - upgrade and provide for new electrical and HVAC services plus larger instructional areas including the addition of an outdoor construction courtyard and three-bay automotive/small engine shop and the creation of a receiving area feedback from the community

Child Care Center - construct a new wing with separate hall way to house six child care classrooms plus an office for SCCC with a secured entrance; remodel multiple exiting classrooms to capitalize on current space

Locker rooms and Gymnasium - remodel and build PE and Team locker rooms for both boys and girls capitalizing on current space and plumbing; relocate the band room and related practice areas to capitalize on current space

Growing Today for Tomorrow's Learners

When considering the many areas of need expressed by the community members and others who weighed-in during the Facility Study meetings, the Committee constantly returned to one guiding principal: build for growth. "We weren't just looking out 4 or 5 years. We were looking out 30 - 40 years and asking ourselves which projects would help us grow today but still meet the anticipated

needs of our learners in years to come," commented Mrs. Schweitzer. "The gyms we have are constantly in use with some of our young learners practicing basketball and wrestling at 8:30PM just so that they can get gym time. The Tech Ed rooms are lacking in physical and electrical capacity, as well as current technology; these areas need to be updated to better prepare our learners for the growing demand in the skilled trade areas thereby providing desperately needed employees to area businesses. SCCC continues to grow in enrollment with over 80 children currently on the roster and many more on the waiting list, a majority of whom are infants. These enrollment numbers indicate that young families want to be in Shiocton; they want to raise their children here and have them go to school here. We need more space to meet the growing need. Secured building entrances are vital to the safety of our students, staff, volunteers, and visitors. Our school offices need to be reconstructed at the front of the

wing so as to more effectively monitor those entering and leaving the building. Plumbing, A/ C, roofing, and electrical repairs continue to be needed; in some cases, the **infrastructure** parts as so old and worn that they can't be repaired nor can we find replacements for them. Aged pipes, insufficient electrics, and incapacitated units are impacting student learning and beginning to "nickel and dime" the District budget beyond available funds."

Community Feedback

While the Committee has set upon the prioritized projects, community member input is vital to the process. Feedback from those attending the **Community Connection** meetings in August will assist the Committee in determining the exact projects that will be presented to the Board of Education for consideration in November. Community members will have the ultimate say on the prioritized project during the February 2024 primary election.

experience of working in city and county government. "On inspiration from my dad, I ran for school board", Sydney said, noting that she looked up to her dad and felt she had some background in what a school board member would need to do. Her run for a seat on the school board included the experience of campaigning and going through an election. She also had the opportunity to work on budgets, which she found challenging since the school board was not given the mill rate, making it difficult to calculate taxes.

Sydney also shared with the Shiocton School Board members the learning she gained related to the process of passing a bill and what an ordinance is. Another learning activity included in the week was the holding of a State Fair, including a talent show that all attendees were encouraged to participate in. Sydney described for the Board how she performed a routine with a few other girls to Just Dance and how doing so was "WAY out of my comfort zone". However, Sydney noted that being in the talent show was a good experience and she ended up having a lot of fun with it.

Sydney feels the week-long conference was very much worth attending. "I would recommend the experience to others because it was like no experience I've ever experienced before; it was fun to learn of all the different roles and responsibilities to run a city or county." Too, Sydney enjoyed the conference because of the ability to meet and interact with new people. "I met a random girl and instantly clicked with her and was able to bond with other people I never knew before."

When asked if she would recommend Badger Girls State conference to others, Sydney indicated she definitely would. "This was really great experience ... it's made me more confident to go to college and this is why people should attend (Badger Girls State). It was definitely worth a week of my time."

Grading Scale Update: Grades 6-12

As you have likely heard, the School District of Shiocton had several discussions and feedback sessions over the last year related to our grading scale, at the time, and whether it created concerns for equity. Those conversations led our Grading Scale Committee to recommend a change to the grading scale to our School Board. The School Board approved those changes starting at the beginning of the 2023 - 2024 school year. This grading scale will be used for all 6th grade through 12th grade students starting at the beginning of the upcoming school year. Please see the table below that lists the changes. SUDDEN CARDIAC ARREST

Sudden cardiac arrest is the leading cause of death in young athletes while training or participating in sport competition. Even athletes who appear healthy and have a normal preparticipation screening may have underlying heart abnormalities that can be life threatening.

What are the symptoms/warning signs of Sudden Cardiac Arrest?

- 1. Fainting/blackouts (especially during exercise)
- 2. Dizziness
- 3. Unusual fatigue/weakness
- 4. Chest pain
- 5. Shortness of breath
- 6. Nausea/vomiting
- 7. Palpitations (heart is beating unusually fast or skipping beats)
- 8. Family history of sudden cardiac arrest at age < 50

ANY of these symptoms/warning signs that occur while exercising may necessitate further evaluation from your physician before returning to practice or a game.

SUDDEN CARDIAC ARREST VS. HEART ATTACK

	Sudden Cardiac Arrest (SCA)	Heart Attack
Definition	SCA is a chaotic electrical condition of the heart resulting in the loss of blood flow to the brain and body. The most common form of SCA is ventricular fibrillation.	The medical term for a heart attack is myocardial infarction: a blockage of the coronary arteries leading to a decrease in blood flow. When this happens, the heart muscles die or become permanently damaged.
Causes	Electrical impulses of the heart become chaotic due to a blow to the chest or other (sometimes- unknown) health-related issues. As a result, the heart stops beating regularly and begins to flutter rapidly.	Plaque made of cholesterol and other cells builds up in the walls of the heart's arteries. When the buildup is great enough, the plaque creates a blockage, known as an occlusion which restricts the blood supply to the heart muscle.
Symptoms	Typically, there are no symptoms to SCA. Usually, the first indication of SCA is when the victim faints. The second sign is breathing cessation.	Warning signs of heart attack include a tightening feeling in the chest, a sore or numb left arm, lower back, neck, and/or jaw. Other signs include bad indigestion, a feeling that something heavy is sitting on your chest, and shortness of breath.
Victim's Response	A sudden cardiac arrest victim always loses consciousness from lack of oxygen.	The victim of a heart attack is usually conscious and alert.
Risk of Death	A victim of SCA will die unless treated. If left untreated, the chances of survival decrease by 10% per minute. Typically, permanent brain damage occurs within 5-7 minutes.	Most victims can recover fully and lead normal lives, but abou a third of heart attacks are deadly. A heart attack can lead to sudden cardiac arrest.
Treatment	The only treatment for SCA is defibrillation from an automated external defibrillator (AED). A shock from the AED stops the chaotic electrical activity and allows the heart's sinus node to resume a normal electrical impulse.	One treatment of a heart attack can be angioplasty, which opens up the blocked vessels with a medical balloon. Afterwards, a stent can be placed in the artery to help keep it open. Other treatments include clot-busting drugs called thrombolytics or nitroglycerin to reduce chest pain.

Salal Notes from the Nurse

The following are the immunization requirements for the **2023-2024** school year for your child. Unless a waiver has been signed, all students are required to have their immunizations up to date on the **first day of the new school year**. Students **entering K5** will need to have a series of vaccines to be compliant with immunization law. Students **entering 7th grade*** will need to receive a Tdap vaccine. Please provide the school with a copy of any new immunizations your child has received. Please plan ahead and have your child immunized prior to the beginning of the school year. * New for the 23-24 school year per DHS: The Tdap vaccine will now be required when entering 7th grade, instead of 6th grade

We are committed as ever to the academic success of all of our students. The School District of Shiocton needs your help to make sure all of our stu-

dents are fully prepared for academic success. We all know that hungry children have a more difficult time doing their best work. That is why we encourage all students to begin the school day with a nutritious breakfast.

The School Breakfast Program is available to all students to purchase every school day from 7:30 a.m. - 7:50 a.m. You do not have to register your child in advance. Your child can eat breakfast at school every day or occasionally. School breakfast makes good sense-it provides ¼ of your child's nutritional needs, meets Dietary Guideline recommendations, and offers children a chance to eat breakfast with their friends.

School Breakfast is an ideal solution on busy mornings when kids are running late or parents have to be at work early. Oftentimes, kids are not hungry when they first wake up, but are ready to eat when school begins. Whatever the reason, if breakfast at home is not convenient, please have your child take advantage of breakfast here at school. Studies have shown that children who eat a nutritious breakfast have better behavior, better attendance, and improved test scores.

Student Record Notice

Governed by Board Policy 8330

The Board designates as student "directory information": a student's name; address; telephone number; date of birth; major field of study; participation in officially-recognized activities and sports; height and weight, if a member of an athletic team; dates of attendance; date of graduation; or awards received.

Directory information shall not be provided to any organization for profitmaking purposes.

Parents and eligible students may refuse to allow the Board to disclose any or all of such "directory information" upon written notification to the Board within fourteen (14) days after receipt of the District Administrator's annual public notice or enrollment of the student into the District if such enrollment occurs after the annual public notice.

In accordance with Federal and State law, the Board shall release the names, addresses, and telephone listings of secondary students to a recruiting officer for any branch of the United States Armed Forces or an institution of higher education who requests such information. A secondary school student or parent of the student may request in writing that the student's name, address, and telephone listing not be released without prior consent of the parent(s)/eligible student.

Whenever consent of the parent(s)/eligible student is required for the inspection and/or release of a student's health or education records or for the release of "directory information," either parent may provide such consent unless agreed to otherwise in writing by both parents or specifically stated by court order. If the student is under the guardianship of an institution, the District Administrator shall appoint a person who has no conflicting interest to provide such written consent.

The Board may disclose "directory information", on former students without student or parental consent, unless the parent or eligible student previously submitted a request that such information not be disclosed without their prior written consent.

The Board shall not collect or use personal information obtained from students or their parents for the purpose of marketing or for selling that information.

Only "directory information" regarding a student shall be released to any person or party, other than the student or his/her parent, without the written consent of the parent, or, if the student is an eligible student, without the written consent of the student, except to those persons or parties stipulated by the Board's policy and administrative guidelines and/or those specified in the law.

RELEASE STATEMENT

The School District of Shiocton announced its policy for children unable to pay the full price of meals served under the National School Lunch Program and School Breakfast Program or milk for split-session students served under the Special Milk Program. Each school office and the central office has a copy of the policy, which may be reviewed by any interested party.

The following household size and income criteria will be used for determining eligibility. Children from families whose annual income is at or below the levels shown are eligible for free and reduced price meals or free milk if a split-session student does not have access to the school lunch or breakfast service.

If a parent or guardian is dissatisfied with the ruling of the official, he/she may wish to discuss the decision with the determining official on an informal basis. If the parent/guardian wishes to make a formal appeal, he/she may make a request either orally or in writing to: Nichole Schweitzer, District Administrator, N5650 Broad Street PO Box 68 Shiocton, WI 54170 920-986-3351 x761.

If a hearing is needed to appeal the decision, the policy contains an outline of the hearing procedure.

If a household member becomes unemployed or if the household size changes. the family should contact the school. Such changes may make the household eligible for reduced price meals or free meals or free milk if the household income falls at or below the levels shown above, and they may reapply at that time.

Children formally placed in foster care are also eligible for free meal benefits.
