Middle School Spanish and EL Teacher

The School District of Shiocton is seeking to develop a pool of candidates for a Middle School Spanish and English Learner (EL) teaching position beginning with the start of the 2024-2025 school year. The position is a 0.5 FTE and will serve our 7th and 8th grade middle school students in the area of Spanish as a Foreign Language, and will serve our district as an English Learner (EL) teacher. The anticipated class load will entail two middle school level Spanish courses and two hours of English Learner support/instruction with K-12 students.

The School District of Shiocton is a rural district in a small, close knit community. Teachers throughout the district collaborate frequently to meet the needs of our students. Shiocton has a great student body, and has a welcoming environment conducive to learning. We enjoy a small pupil to teacher ratio that aids in our students' achievement.

Successful candidates will demonstrate fluency in Spanish, as well as a drive to work with students of all ages. Successful candidates should also have a proven background in Foreign Language instruction, including alignment of instruction to World Language standards. Familiarity and/or experience working with English Learner students is preferred.

Applicants should be energetic with a strong desire to also work with parents, colleagues, and administration to meet the needs of our students. Successful candidates will also have demonstrated effective use of technology and best instructional practices. Successful candidates will also possess strong interpersonal communication skills.

JOB TITLE: Middle School Spanish and EL Teacher (0.5 FTE)

PURPOSE OF POSITION:

The purpose of this position is to assist in the learning process, which may take place in the traditional classroom or, in the employment of Digital Learning Days, this learning process may take place to/from a remote location.

SUPERVISORY RESPONSIBILITY:

Students in the classroom, hallways, site and at school events.

PRIMARY RESPONSIBILITY:

The education of our students in the areas of 7th and 8th Grade Spanish, and provide education and support to our English Learner students. These duties and responsibilities are illustrative only and may include other duties and responsibilities as assigned and appropriate.

INSTRUCTIONAL

- Understands the central concepts, tools of inquiry, and structures of disciplines being taught and can create learning experiences that make these aspects of subject matter meaningful for students.
- Solid understanding of the CCSS (Common Core State Standards) as they relate to Middle School Spanish...
- Understands how students with broad ranges of ability learn and provides instruction that supports their intellectual, social and personal development.
- Understands how students differ in their approaches to learning and the barriers that impede learning and adapts instruction to meet the diverse needs of students, including those with disabilities and exceptionalities.
- Strong content knowledge of Spanish as a Foreign Language.
- Possess fluency in the Spanish language.
- Strong knowledge of how to support EL students within the classroom setting.
- Understands and uses a variety of instructional strategies, including the use of technology, to encourage student's development of critical thinking, problem solving, and performance skills.
- Uses standards-based teaching and learning to provide opportunities for all students to reach high learning expectations. Establishes clear learning targets for all lessons, units, and projects.
- Uses an understanding of individual and group motivation and behavior to create a learning environment that encourages positive social interaction, active engagement in learning, and self-motivation.
- Uses effective verbal and non-verbal communication techniques as well as instructional media and technology to foster active inquiry, collaboration, and supportive interaction in the classroom.

- Ability to maintain a positive learning environment.

WORKING ENVIRONMENTAL CONDITIONS

Work is performed primarily in the classroom environment where the professional educator may be exposed to students who express inappropriate types of behavior and/or feelings under normal circumstances and/ or a general precisive mood of unhappiness and depression and/or a tendency to develop physical symptoms or fears associated with personal or school problems. The teacher may be exposed to sick and/or injured students or staff.

PHYSICAL AND SENSORY REQUIREMENTS

This position requires the educator to:

- Sit and walk throughout the day
- Lift and or carry books, computer paper or other teaching materials
- Climb stairs
- Reach, stoop, and bend to perform classroom activities
- Use general hearing, speaking and visual skills
- Excellent verbal communication stills for instructing students
- Use of cognitive reasoning to interpret, report, compare, edit, organize, evaluate, etc.
- Computer electronic device proficiency

PROBLEM SOLVING

Examples of typical problem solving include a variety of situations in and out of the classroom setting. Daily situations require analysis and judgment to apply the best solutions. Examples of typical independent judgments include evaluating students according to District, State, and Federal policies, procedures and appropriate regulations. Additionally, this position required problem solving skills related to working students, parents, and colleagues.

COMMUNICATION AND INTERACTION

Position requires various contact and interaction with co-workers, professional educators, students, school-site administrators, cluster or District-level supervisors or administrators, parents, general public, vendors, bidders, service providers, outside agencies (Federal, state, local government), uncooperative, angry or hostile individuals, special interest groups such as education, community, parent, union, superintendent, board members, and state or federal elected / appointed officers

MINIMUM EDUCATION, EXPERIENCE, CERTIFICATIONS:

Applicants must possess or have the ability to be licensed for a Wisconsin DPI License – Middle School Spanish (1365 and. EL License (1395) is preferred.
